Griffin is a Commission-Manager form of government with seven commissioners who direct the operations of the City government through a City Manager. Services of the City are directed by seven Department Directors including Administrative Services, Central Services, Planning & Development, Public Works & Utilities, Electric., Police and Fire. The Deputy Director of Water & Wastewater reports directly to the Director of Public Works & Utilities.

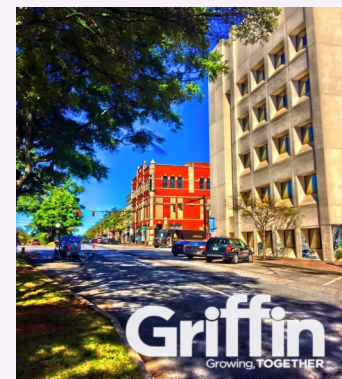
